## **Drawing Revisions**

- 1. A recessed public bench has been added on Pandora Avenue.
- 2. A walkway has been added from the Pandora sidewalk to the entry of the south/west corner unit.
- 3. Cascading plants in the planter on Pandora have been removed.
- 4. The bench in the planter on Camosun Street has been removed; the fire hydrant has been added to the plan.
- 5. A bench has been added to the planter by the main entrance of the project.
- 6. The PMT has been shifted to the edge of driveway; the landscape around it has been redesigned.
- 7. Utility labels have been added to the plan.
- 8. The label for the landscape feature has been revised.
- 9. The tree planting plan has been revised; one additional small boulevard tree has been added on Pandora Ave.
- 10. The tree planting schedule has been revised; Armstrong Maple and Serviceberry were removed, Eddie's White Wonder Flowering Dogwood was added.
- 11. The soil volume analysis has been updated (by Gye and Associates).
- 12. A planting schedule has been added for the upper level planter plan; planters were added to address the concern of overlook into neighbouring properties. Drawing sheet renamed 'Planter on Patio Level 4 & 5'.
- 13. A new sheet L6 has been added for planters on balcony railings; planters were added to address the concern of overlook into neighbouring properties. Section and planting plan added. A section of the planters on patio was also added to L5.
- 14. A lighting plan has been added.
